The Town Supervisor is the Chief Elected Officer in town government. The Supervisor is responsible for the day to day operation of town business which includes receiving residents' inquiries and grievances. The Supervisor establishes all committees and appoints its members, liaison officers, a deputy supervisor and conducts all negotiations with bargaining units.

The Supervisor is the Chief Administrative Officer of the Town and presides at all meetings of the Town Board. After Town Board decisions have been made, it is the Supervisor who carries out the decisions. He executes all Town Board authorized contracts on behalf of the Town.

As the Town's Chief Fiscal Officer, the Supervisor has ultimate responsibility for all monetary transactions and investments. State mandates require a detailed financial report be prepared annually by the Supervisor.

The Supervisor has been designated as Budget Officer and has responsibility for preparation of the Town budget.

The Town Supervisor and the Town Board are the legislative body for the Town and have control over legislation, appropriations and policies.

The Town Board is composed of the Town Supervisor who is elected to a two year term of office and four council members who are each elected to a four year term of office.

The Town Board conducts public meetings each month on the first Wednesday of the month.

The Board's functions include the awarding of all contracts and bids, providing for town improvements and adopting and amending local laws. The Board establishes all positions within the Town, appoints personnel and sets salaries and benefits.

One of the most important duties of the Town Board is the adoption of the annual budget. The monies to run the town government are raised in the budget which is prepared and adopted during the preceding fiscal year. Taxes collected during January of each year are used to operate town government.

The Animal Control Officer is responsible for enforcing the Town of New Windsor dog control ordinances.

All dogs over the age of four months are required to be licensed and vaccinated against rabies. Licenses are obtained in the Town Clerk's office and must be renewed annually.

The Town of New Windsor does have a leash law. Dogs are to be leashed or confined at all times. No dog is permitted to run at large on any public place, street, avenue, road or highway.

**The Building Department** administers and enforces the New York State Uniform Fire Prevention and Building Code regulations and New Windsor Zoning laws pertaining to the location, design, materials, construction, alteration, repair, equipment, maintenance, use, occupancy, removal and demolition of structures located within the Town.

Electrical work is inspected by independent agents certified by the State of New York. Please call the office for a complete list of authorized electrical inspectors.

**The Fire Inspector's Office** is responsible for all plan reviews of new projects pertaining to fire safety related issues and safety inspections of existing structures to include all commercial occupancies, multi-family occupancies, motels, schools and public places of assembly.

All safety and health inspections are in compliance with the Fire Code and Property Maintenance Code of New York State and the Fire Prevention Code of the Town of New Windsor. The Fire Inspector's office monitors hazardous manufacturing processes and the storage or installation of gases, chemicals, oils, explosive and flammable materials.

The Fire Inspectors also review water mains and fire hydrant locations, they issue and review 911 building numbering requirements and are the lead agency involved with all fire investigations within the Town.

The Buildings and Grounds Department is responsible for maintenance and support of all town-owned and leased properties - its buildings and their furnishings and equipment, grounds and infrastructure. ### Grass Clippings, Leaves and Brush Collection

Pickup is every other week alternating with recycling pickup. Branches must be less than three inches in diameter, no longer than three feet in length and must be tied in bundles.

### Metal Pickup

Pickup is Tuesday and Thursday afternoons. Poles should be no longer than four feet in length. Refrigerators, air conditioners or freezers cannot be picked up. These should be brought to the Orange County Transfer Station, 9 Orr Avenue, Newburgh. Call (845) 291-2664 for more information.

## NEW WINDSOR TOWN COURT JURISDICTION INCLUDES

The Justice Court is the first level trial court of New York State's Unified Court System. Many New Yorkers will have their first and only court experience in a town or village court. The justices respond to arraignments, orders of protection, and search warrants from law enforcement officers on a 24-hour, seven day a week schedule.

Justice Court has preliminary jurisdiction over felony cases and exclusive jurisdiction over misdemeanor cases, pending divestiture to the County Court. Small claims and civil cases up to \$3,000.00 are also handled in Justice Court.

*Marriages are performed by appointment only.*

The New Windsor Justice Court is open to the public and the public is welcome to attend court sessions.

The New Windsor Police Department is a full time public service agency providing 24-hour law enforcement coverage and emergency dispatching services to the Town. All police, fire and emergency medical needs are dispatched from Police Headquarters located at the Town Hall Complex.

Police Chief Daniel Valeri is a graduate of the FBI's National Academy located in Quantico, Virginia.

The Police Department achieved New York State accreditation from the New York State Accreditation Council in 1996 and has been continuously accredited since.

The Police Department is staffed by forty-four full time officers, twenty full and part time civilian staff members and two police canines.

The Department provides a full range of services to the community, from investigating serious crimes to providing community outreach.

A drop box for prescription medications is available in the lobby of the Police Department. For more information on what can be dropped off, please see information on our website.

The Police Department has set up a Safe Exchange Zone for internet transactions or custody exchanges. It is an area outside the Police Lobby and has 24-hour camera surveillance.

## PROPERTY TAX COLLECTION JANUARY 1 – MARCH 31

Property tax bills are mailed out the last week of December.

- Payments made through January 31<sup>st</sup> are without penalty.
- Payments made in February are charged a 1% penalty.
- Payments made in March are charged a 2% penalty + \$2.00 notice fee.
- After April 1<sup>st</sup>, all unpaid tax bills are sent to the Orange County Commissioner of Finance for collection.
- Payments received with a USPS postmark on or before the due date are deemed as on time.

The Town of New Windsor Sewer Department operates and maintains the wastewater treatment facility, as well as the main sewer lines throughout New Windsor. The Town owns the main sewer lines, while connections from homes to these main sewer lines are owned by and the responsibility of the homeowner.

Our mission is to clean wastewater and to return it safely to our environment. In order to accomplish this task, we offer the following services to Town residents:

### BACKED UP SEWER LINES

If a homeowner's sewer line is backed up, the Sewer Department will, at no charge, check the Town's sewer line to determine the origin of the backup. Should the cause be with the Town's line, the Sewer Department will take immediate corrective action. If the backup is in the homeowner's line, the Town will make suggestions for corrective action.

### LOCATING SEWER LINES

If a homeowner needs to identify or mark-out the location of their sewer line and connection to the Town's sewer main, the homeowner should contact 'Dig Safely New York' at 1-800-962-7692 and request their assistance. The Sewer Department is only responsible for mark-outs of the Town's sewer line. If the Sewer Department is called upon to mark-out a private homeowner's sewer line and connection, the Town shall assume no responsibility for the accuracy of the same. The homeowner and/or the homeowner's contractor requesting the mark-out shall retain all responsibility and liability for any work done in connection with the requested mark-out of the homeowner's sewer line.

### SEWER INSPECTIONS

Our department is available for sewer inspections during regular business hours for those residents who have a valid sewer permit from the Town. Please call the Sewer Department at (845) 561-2550 at least 24-hours in advance to schedule an inspection.

- Answers customers' inquiries regarding their utility bills and water usage.
- Reads and records readings from domestic and commercial meters.
- Schedules final inspections of water meter installations.

## WATER TREATMENT PLANTS

The Town's goal is to produce the highest quality drinking water for all of our customers. All water plant operators are licensed by New York State.

Our plant operators routinely collect and test water samples checking for purity and identifying potential problems. Our water plants are constantly maintained, evaluated and upgraded to stay abreast of advancements in technology, science, health and government regulations.

Approximately 3,000,000 gallons of water per day are delivered to approximately 29,500 water customers. There are 5,573 service connections.

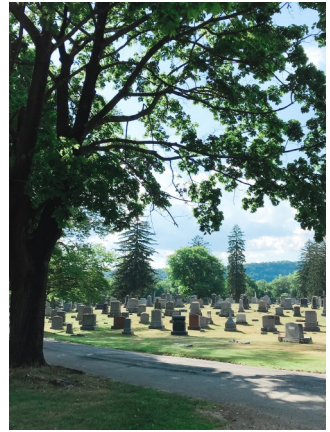
